The manpower for these resources are not required to meet the National Wildfire Coordinating Group (NWCG) credentialing requirements (Red Card), however, they will need to be South Dakota Certified Structural Firefighters and have completed the NIMS ICS 100, 200 and 700 classes. Manpower participating in this plan will need to have their training/certification information entered into the Incident Qualifications System (IQS) database managed by the SD Wildland Fire Division, so a Credentialing card showing that the individual meets these minimum requirements can be printed out for that individual. This card will need to be carried by that individual and provided upon check in to an incident.
