History

- National Voter Registration Act (also known as NVRA or the Motor Voter Act)
 - Signed in 1993 by President Clinton
 - Sets forth certain voter registration requirements with respect to elections for federal office.
 - Section 5 Motor Vehicle Agencies requires that States offer voter registration opportunities at State motor vehicle agencies.
 - Section 6 Mail Registration requires that States offer voter registration opportunities by mail-in application.
 - Section 7 Voter Registration Agencies requires that States offer voter registration opportunities at certain State and local offices, including public assistance and disability offices.
 - Section 8 Administration of Voter Registration contains requirements with respect to the administration of voter registration by States and requires States to implement procedures to maintain accurate and current voter registration lists.

- Each State motor vehicle driver's license application (including any renewal application) submitted to a State motor vehicle authority must serve as a simultaneous voter registration application unless the applicant fails to sign the voter registration application. This application for voter registration must be considered as updating any previous voter registration by the applicant.
- Any change of address form submitted for State driver's license purposes must also serve as notification of change of address for voter registration purposes unless the registrant states on the form that the change of address is not for voter registration purposes. This means that all changes of address submitted to State motor vehicle offices must be forwarded to election authorities unless the registrant affirmatively requests otherwise by opting out on the form.

- This applies to all license transactions with driver's license offices.
- The NVRA defines the term 'motor vehicle driver's license" to include "any personal identification document issued by a State motor vehicle authority", making the voter registration opportunity apply to applications, renewals, and change of address transactions regarding any personal identification document issued by a State motor vehicle authority (including remote applications for driver's licenses, driver's license renewals, or driver's license changes of address, via mail, telephone, or internet or other means).

- Each State must include a voter registration form as part of an application for a State driver's license and any application for driver's license renewal.
- The voter registration portion of the application may not require any information that duplicates information required on the driver's license portion of the application and may require only the minimum amount of information necessary to prevent duplicate voter registrations and permit State officials both to determine the eligibility of the applicant to vote and to administer the voting process.

The voter registration application must state each voter • eligibility requirement (including citizenship), contain an attestation that the applicant meets each requirement, state the penalties provided by law for submission of a false voter registration application and require the signature of the applicant under penalty of perjury (red box). In addition, the application shall also include statements specifying that: 1) if an applicant declines to register to vote, the fact that the applicant has declined to register will remain confidential and will be used only for voter registration purposes; and 2) if an applicant does register to vote, the identity of the office at which the applicant submits a voter registration application will remain confidential and will be used only for voter registration purposes (blue box).

- Once the voter registration application is completed, they must be transmitted to the appropriate State election official no later than ten days after acceptance.
- If an application is accepted at a motor vehicle agency within five days of a voter registration deadline for an election, the application must be transmitted to election officials no later than five days after acceptance. The agency providing voter-registration services may not require a registrant to mail in the form himself or herself or discourage him or her in any manner from submitting the form to the agency. Similarly, if it is agency practice to make sure that agency forms are completed and signed when submitted by an applicant, the same practice should apply to a voter registration application submitted by that applicant.

Required Information to Register to Vote

- First and Last name
- Residence address IN SOUTH DAKOTA if no physical residence address, they need to provide a description (under the bridge on 4th street, etc)
 - The mailing address may be out of state or a PO BOX
 - If the PO Box is listed as the residential address, please let the voter know they cannot list a PO Box address as their physical address.
 - You, as the examiner, do not make the determination if a person is qualified to register to vote.
- Date of Birth
- South Dakota Driver's license number
- Last four digits of their Social Security Number can only be used if they do not have a SD Driver's License.

Required Information to Register to Vote ont

- NEW THIS YEAR If they do not have a SD Driver's License OR an SSN, the examiner must provide voter registration services.
 - <u>Examiner will need to provide a personal identification affidavit to the applicant.</u>

Required Information to Register to Vote cont.

Voter Registration Services for Applicant Presenting with No Identifying Number (Driver's License, Non-Driver ID Card, Social Security Number)

Applicant completes identifying information section of DL application and voter registration section.

Applicant completes voter registration affidavit affirming they don't have identifying number. Notary will sign & attach seal. If unable, in good faith, to verify person's identity, not required by law to notarize the person's signature.

Application/Voter Registration and affidavit will be sent directly to the appropriate County Auditor's office.

Do not update SD DRIVERS with this type of registration. Notify DPS NVRA Coordinator that you processed this type of application and sent it to the appropriate County Auditor.

Include the date the application was received, the date it was sent to the County Auditor, and which auditor's office the information was sent to.

Required Information to Register to Vote cont.

- Choice of Party
 - We encourage the individual to fill this section out, however if left blank, the system on the Secretary of State's side will fill it in with IND/NPA or if the voter is currently registered, it will pull the choice of party on their current voter registration). You do not fill anything in if this field is left blank.

Effective July 1, 2019

12-4-15. A person may designate or change that person's party affiliation, name, or address by completing a new registration card. For any registration card completed by a person changing that person's party affiliation, name, or address, if the field for party affiliation is left blank, the person's party affiliation shall be the most recent party affiliation registered for that person. For any registration card completed by a person who is registering to vote for the first time in this state, if the field for party affiliation is left blank, the party affiliation shall be registered as independent or no party affiliation.

If an individual leaves this line blank, you will leave it blank in the DLVR system!

Unofficial Political Parties in SD cont.

- Independent (IND)/No Party Affiliation (NPA) these are one in the same.
 - IND: Independent, I, Ind
 - NPA: No Party Affiliation, no party, no choice, none, non-partisan, line crossed off, or the field is blank

South Dakota does not have an Independent Party

SDCL 12-1-3 (22) Defines "Independent (IND)" or "no party affiliation (NPA)," as follows: Any currently registered voter who writes independent, I, Ind, no party affiliation, no party, no choice, nonpartisan, or line crossed off in the choice of party field on the voter registration form and any individual who is not currently registered to vote who leaves the choice of party field blank on the voter registration form;

If an individual leaves this line blank, you will leave it blank in the DLVR system!

Personal or Private Mailbox (PMB)

- Full-Time RVers often use PMBs as their "residence" address to vote.
- Larger PMBs are located in Lake, Minnehaha, Hanson, Pennington and Brule counties.
- We receive calls from RVers, asking how to fill out the form. We instruct them to read the "I declare" statement and make their own determination.
- You do not make the determination if a person is qualified to register to vote

Ensure Accuracy

- Voter's address is linked to a specific jurisdiction.
- Every voter has two or more of the following jurisdictions:
 - State House
 - State Senate
 - Municipal
 - School District
- Voters can also have the following:
 - Ambulance District
 - County Commissioner District
 - Municipal Ward
 - Sanitary District
 - School Board Representation Area
 - Water District
 - Road District
 - Fire District
 - Consumer Power District
 - Other special districts

- Each of these previous districts can have an election.
- Not entering the information correctly can cause someone to be linked to the incorrect jurisdiction.
- This results in not being eligible to vote in their election.
- The county auditor receives the voter registration information from Driver's Licensing by an electronic data feed.
- Data entered by Driver's Licensing is what the county auditor receives.
- The county auditor may not catch a mistake if you enter the information incorrectly.

- Wrong spelling of name
- Last name entered in as first name
- First name entered in as middle name
- Middle name entered in as last name
- Political party entered incorrectly
 - Ask Do you want to leave this blank?
- County name entered incorrectly
- Date of Birth entered incorrectly
- Ensure the apartment number isn't left off
- Wrong zip code entered

Example #1

- John Smith registered to vote at his local driver's license exam station prior to the VR deadline.
 - He lives at 123 Main St. in Pierre, SD, but the person entering his voter registration information enters 1123 Main St.
 - 123 Main St. is in Ward 1.
 - 1123 Main St. is in Ward 2.
 - Ward 1 is having an election and John Smith shows up at the polling location. He would not be on the voter registration list because he is linked to Ward 2 because he was entered in as 1123 Main St.

Example #2

- Someone shows up at the polling location to vote and their name is not on the registration list. Person insists that they registered to vote at the Driver's Licensing Exam Station.
 - Pollworker calls county auditor.
 - County auditor contacts the Secretary of State's office.
 - SOS office contacts Driver's Licensing to pull the app or SOS staff finds the app themselves in FileDirector.
 - Driver's Licensing/SOS retrieves the original Driver's License application.
 - SOS office receives original application and contacts the county auditor.
 - County auditor contacts pollworker.
 - Person is allowed to vote if the person did in fact check "Yes" on the original application.

Example #3

- Sample application where the voter marked the box "Do not use my information for voter registration purposes" but then initials on the top.
- Always error on the side of the voter and pass on the registration.
- Also, if you see them fill in any information below, better to send it on.
